

Clinton Township Board of Trustees – Regular Meeting
January 8, 2018 – 7:00 p.m.

All Board members answered roll call – Trustee Dennis Moyer, Trustee James Distel, Trustee Dennis Baugher, and Fiscal Officer Jennifer Bates.

Guests: Fred Bishop, Eric Bishop, Frank Laney, Diana Warnement, Phyllis Watts, and Dennis Kingseed.

The minutes of the organizational meeting held January 2, 2018 were read and approved.

Correspondence: Seneca County Prosecutor- memo regarding sale of obsolete air masks, OSS Solid Waste District- memo regarding additional pick-up day at Station #2

Fire Chief Fred Bishop submitted his annual report for 2017. He reports that their ISO rating went down from a 6/9 to a 5/5Y. He also needs to order some replacement valves for the trucks. Regarding the sale of the old air masks, Chief Bishop says they are probably only worth a couple hundred dollars each. There are 12 masks, but 3 or 4 are broken. Chief Bishop also reports that all 5 firefighters in training passed Firefighter I.

Trustee Baugher motioned to pass Resolution 2018-1 to authorize the sale of the old air masks through private sale. The estimated fair market value of each mask is under \$2,500. This motion was seconded by Trustee Distel. Mr. Moyer – yes, Mr. Distel – yes, Mr. Baugher – yes.

Zoning Inspector Frank Laney asks the Board if they had any questions regarding the 2018 zoning fees. He researched zoning fees in other townships in Ohio. In most cases, our fees are much lower. He did do some small increases and increase the fee for new houses from \$45 to \$100.00. Many other townships are charging an additional fee based on square footage.

Resident Dennis Kingseed asked if the addition of a 4th pick-up day for recycling is for both locations, or just Station #2. The Board understood it to mean that only Station #2 will be adding Tuesday pick-up.

Trustee Baugher says he thinks we should put “road closed” signs on the barricades at TR 177.

Trustee Distel reports that he attended the ribbon cutting at the new Regional Planning and Board of Elections offices on January 4th. Trustee Moyer attended the OSS Solid Waste District grant meeting.

Trustee Distel asks if we need to do anything regarding the annexation agreement with the City of Tiffin. When the Board talked to the mayor last year, he was okay with leaving the agreement the same. Trustee Distel believes the agreement expires this September. He will talk to Mayor Montz again and see what needs to be done.

Regarding extra help for the road department, Trustee Distel has spoken to people who have used the sheriff department’s inmate work crew for labor and have been happy with the program. He suggested that we look into it for help with crack filling.

Trustee Moyer suggests that the Board looks at the job descriptions for the road department and see if there are any changes that should be made now that there is only one road worker.

Trustee Moyer reports that we received the barricades that were purchased with the M.O.R.E. grant. He also says the Board will need to appoint someone to replace Jim Wise on the Zoning Board of Appeals. Also, Grant Kneeskern’s term expires this year. The Board will contact him and see if he will serve another term.
