## Clinton Township Board of Trustees – Regular Meeting November 11, 2019 – 7:00 p.m.

All Board members answered roll call – Trustee James Distel, Trustee Dennis Baugher, Trustee Dennis Moyer, and Fiscal Officer Jennifer Bates.

Guests: Fred Bishop, Steve Welter, Jim Lang, Dennis Kingseed.

The minutes of the meeting held October 28, 2019 were read and approved.

Correspondence: Grassroots Clippings, Seneca County Regional Planning – Joint Comprehensive Plan community input meeting invitation, Seneca County Prosecutor – memo regarding Winterberry Farms zoning

Fire Chief Fred Bishop reports that six firefighters attended training at Ehove on Saturday. Also, Truck #32 is having brake issues and is at Keller's for repairs.

Zoning Inspector Steve Welter reports that he issued a permit to Kendall Stucky for a shed and to Steve Hickey for an addition on his house and garage. He also received an application for re-zoning from Gary Gruss for three parcels on SR 101. Zoning Inspector Welter also spoke to Daryl Moyer regarding a pro-life sign they want to put up at St. Mary's Cemetery. Zoning Inspector Welter was unsure how to classify the sign, and after speaking to former zoning inspector Bob Reinhart, they agreed that it would be considered a billboard. Zoning code says that you cannot have another billboard within 1,000 feet, so this would require a variance, and Mr. Moyer was unsure that they would want to pursue it at this time.

Regarding Winterberry Farms, Zoning Inspector says the agribusiness classification is a bit of a gray area. The information received from the prosecutor's office says that if more than 50% of their income is from weddings and events that are not considered farm-related, then they do not qualify as agri-tourism. Ellie Anderson suggests that we meet with the owner, Sabrina Schneppat, and go over the information with her to see what applies to her situation. She also says that even though the property is zoning Agricultural, they are still subject to fire inspections and occupancy permits. Trustee Distel says that Ms. Schneppat did reach out to Richland County when she first got started. He wants to make sure that we are supportive of her business.

Trustee Baugher reports that he called Neil Podach about boring under TR 122 and he says he forgot about it, but will meet Trustee Baugher down there sometime this week. He also reports that Mrs. Allen's driveway approach at Honeycreek is done.

Trustee Moyer reports that the blue address signs came in.

Trustee Distel reports that State Representative Bill Reineke introduced new legislation that would give the township trustees a say in whether wind farms could be constructed in the township. Trustee Distel thinks it still needs to go to the Senate for approval, and then may be a ballot issue.
