Clinton Township Board of Trustees – Regular Meeting February 26, 2024 – 6:00 p.m.

All Board members answered roll call – Trustee Dan Schmitz, Trustee Jim Distel, Trustee Randy Kuhn, and Fiscal Officer Jennifer Bates.

Guests: Steve Welter, Denny Wilkinson, Jim Lang, Ray Bishop, and Paul Shoemaker.

Correspondence: Seneca County Engineer - driveway permit

The minutes of the regular meeting held February 12, 2024 were read and approved.

Zoning Inspector Steve Welter reports that he took phone calls about setbacks for an addition and a permit for a house. He also took a call about running a construction business on N. SR 53 and says the property is zoned General Business but the business can only be operated in-doors. He says he is just going to be storing his equipment in a building.

Assistant Chief Denny Wilkinson thanked Trustee Schmitz and Jim Lang for getting the gear washer operational again. He also says Jeff Bish is complaining about open burning at his neighbor's property so Chief Hafley is drafting a letter to the resident and also going to have the sheriff's department go out and issue a report. Asst. Chief Wilkinson also says they met about the upcoming solar eclipse, and they plan to man the stations beginning at noon on Sunday, April 7th.

Trustee Schmitz says we should get a light out by the fuel pumps so they can see. He also asks what we are going to do with the old generator and says the fire department asks if we can move it to station #2. Asst. Chief Wilkinson says it was without power earlier in the week and they would have to manually open the overhead doors. The Board thinks it is a great idea and Trustee Distel will call Clouse Electric to get a quote on installing it.

Paul Shoemaker asks if he can use the recycling drop-off even though his house is not built yet and the Board says he can.

Trustee Distel turned in his Sunshine Laws training record. He also says the grader is currently up for bid and bids close on Wednesday. There are currently no bids but they have had phone calls and WMS expects bid activity during the last hour of the auction.

Trustee Distel says Chris Magers at Clinton Heights Golf Course called and says they are going to have parking for cars during the eclipse and asked about putting up temporary parking signs 14 days in advance. He directed him to contact Zoning Inspector Welter. If roads are jammed we can also direct people to go park there. Also, Mohawk Local Schools sent out a newsletter with tips for the eclipse including having plenty of food and water at your home before April 5th and switching your cell phones to wi-fi calling.

Trustee Distel says Mike Elchert recently rebuilt a salt spreader and has it for sale. He wants \$3,500 for it. The Board discussed getting it for the pick-up truck and Trustee Kuhn says he is concerned about getting salt all over the back of the truck. Trustee Distel and Jim Lang discussed taking it out with the backhoe when they are not using it so the truck can be cleaned out. Trustee Distel made a motion to purchase the stainless-steel slide-in salt spreader from Mike Elchert for \$3,500, seconded by Trustee Schmitz. Mr. Schmitz – yes, Mr. Distel – yes, Mr. Kuhn – yes.
