

## Clinton Township Board of Trustees – Regular Meeting

December 29, 2025 – 6:00 p.m.

The Following board members answered Roll Call Trustee Dan Schmitz, Trustee Randy Kuhn, Trustee Jim Distel and Fiscal Officer Steve Welter.

Guests: Ray Bishop, Jeff Hohman, Andy Kimmet, Denny Wilkson, Deb Wilkson, and William Mckinney.

The minutes of the regular meeting held December 15, 2025 were read and approved.

### Correspondence

Fiscal Officer Welter reported receiving a calendar from OTARMA, a Christmas card from Diversified Graphics, along with new pricing sheets from MGQ, MGM, and Heidelberg Materials. Fiscal Officer Welter reported receiving the oath of Office for Bill Mckinney from Judge Best Office.

Deputy Chief Wilksens reported that the Fire Department was at 511 runs for the year. The preconstruction meeting for the new fire truck is scheduled for January 16, 2026 in Bay City Michigan. Chief Hafley got the contract all signed. Deputy Chief Wilkson thanked Trustee Schmitz for his years of service to Clinton Township.

Zoning Inspector Hohman reported that he just received a variance request for Dollar General putting a store in front of Camden Falls. He will be forwarding it to the Variance board. Zoning inspector Hohman asked the trustees if they have heard any more about the Ron Fry property and EZ Tree Service. The time limit for the conditional use to have a fence up and building up has come and gone. Zoning inspector Hohman and Mike Landers have gone out and inspected to see if he has completed the requirements and he has. The Trustees reported that they have not heard anything. Zoning Inspector Hohman reported that a resident reported that the owner at 1663 E St Rt 53 put a building up and damaged a field tile. Zoning inspector Hohman asked if he has to fix the field tile. The Trustees said yes. Zoning Inspector Hohman said he would talk to him about fixing the field tile and getting a permit for the building. Zoning Inspector Hohman said that at the last meeting it was brought up about people inquiring about data centers. Zoning inspector Hohman said he has had a call about the old Hayes Albion property inquiring about a data center. He said that the firm inquiring said that the rail road tracks are too close for their project. Trustee Schmitz asked if Trustee Distel had a conversation with the county commissioners about zoning for data centers. Trustee Distel said he spoke to the commissioners and told them to talk to Eden township because they have had a call about property for data centers. The commissions said they have not heard anything yet.

Road worker Andy Kimmet reported that the spreader is on the dump truck and ready to go and he is waiting on parts for the pickup spreader.

Fiscal Officer Welter reported that he printed off last year's Organization meeting for the next meeting.

Trustee Distel also contacted Clouse Electric about getting an estimate for installing the generator for station number two and have not received it as of yet. Trustee Distel said he thinks we should act on the insurance proposal that was presented at the last meeting.
